**Dog Walk Rules - \$25 Registration Fee (Includes Woofstock Tie-dye T-Shirt and Goodies)**

- Children less than 13 years old must be accompanied at all times by a parent/guardian.
- Each person (regardless of age) can only walk one dog.
- Fixed leashes (6 foot maximum) must be used. No retractable leashes.
- The dog's rabies tag or certificate of current vaccination must be with the walkers.
- Walkers are responsible for cleanup behind their dogs. Bring your own poo bags.
- Walkers are responsible for providing their dog with access to water and shade.
